Total for 22 years 7,995 tons of drugs off the streets. Idaho 9,250 lbs. (5 tons) just this year. Reminder to make sure your drug awareness charity information gets in. National Drug Awareness has put up a new u-tube video. TIPS training — every lodge should be involved and employees TIPS trained. Drug Awareness awards will be on the State Secretaries desk for pickup. The report concluded and she moved for the adoption of these reports, motion was seconded and approved by hand vote.

State President Roberts reminded all that the Insurance from Grand Lodge is continuously going up. One way to curtail is to get your bartenders and servers TIPS trained.

Regarding Grand Lodge all 8 states of Area 8 will be at the same hotel. A large reception is planned at the Atlanta Elks Lodge. Keith will be giving his final speech in Atlanta, and they are so looking forward to coming home.

Idaho Elks Rehab Development/Elks Liaison Report & presentation Grant Jones

Grant presents guest speakers from across the state of Idaho. Panelist include Jim Broyles representing Valley Vista project in St. Maries, Michelle Tucker Rehabilitation Director Bonner General Health in Sandpoint, Mark Fiesline Rehabilitation Manager at Benewah Community Hospital in St. Maries.

Overview of project in Sandpoint at BGH. Grants have been acquired through IER since 2016 for rehabilitation equipment. BGH has 4 rehabilitation locations and is a critical access hospital, so funding is an issue. When funds are received for rehab equipment can be acquired, we are able to provide services locally rather than having the patients travel for care, which is critical to healing.

Overview of project in Benewah Community Hospital. They have received 6 grants which were used for equipment, and training to advance the skillsets the of employees in the rehab department. An outdoor facility relative to everyday environment was constructed. And essential training for lymphedema therapy was obtained.

Overview of Valley Vista project in St. Maries. IER have ½ million dollars into 1 facility in North Idaho. The impact is remarkable and has led to personnel changes, space changes, care changes and incredible technology. The community impact was huge, as we protected salaries and professionals into the community and because we can give higher level patient care

The Idaho Elks Rehab System has always been involved in patient outcomes, and these testimonials show that we are continuing to impactful patient outcomes across the state.
